## Title of Course: Impact of Substance Abuse on Education

#### **Course Description:**

This course will be an introductory examination of the current trend of illegal drug use among the student population. Important facets for educator awareness to be explored include the current "fashionable" drugs, how the drugs are distributed and used, and the negative short and long term risk factors of drug abuse. Educators will also become more aware of warning signs, intervention and prevention, and various support systems. Additionally, participants will study how prolonged drug use impacts a child's brain development and future.

## **Overall Course Objective and Expectation(s):**

The objectives of this course are to examine the current trend of illegal drug use among the student population. Important facets for educator awareness to be explored include the current "fashionable" drugs, how the drugs are distributed and used, and the negative short and long term risk factors of drug abuse. Educators will develop awareness of the warning signs, intervention methods, prevention strategies, and various support systems. In addition, participants will examine how prolonged drug abuse impacts a child's brain development and academic success.

## **Course Instructional Materials:**

All courses maintain a fully developed and dynamic webpage that houses all resources, reference material and various other required informational texts, videos and alike that is both active and relevant to course objectives and content. Course web pages are routinely updated to reflect most current research and available readings therefore instructional materials used to teach course objectives are subject to change.

## Instructor Consultation and Interaction

The course is an asynchronous online course that is available for instructor and student participation 24/7. The four week duration of the class is broken down into four weekly sections each comprised of lecture in the form of instructor created articles and content, web links to academic and professionally reviewed articles in the discipline of general education, and instructor created discussion questions which are, in and of themselves, formative assessments to determine the extent to which the enrollees have comprehended and mastered the information and begun to apply it to their personal teaching practices. The answers to these questions are the basis for the class interaction, as enrollees are required to respond to each other within the classroom arena.

By providing a wide variety of professional articles, peer reviewed journal pieces and researched instructor created content that addresses the needs of all K-12 educators and by encouraging interactive dialogue among the enrollees, this course will encourage and require application, discussion and peer feedback of said strategies and understanding in teaching students within a teacher's own individual classroom practices. The discussion and feedback will give us our own meta-assessment of useful, research based and practiced strategies and techniques for addressing the needs of our varied students thus giving them more opportunity to truly excel.

#### **Proof of Course Completion:**

LILIE, LLC is committed to assuring that enrollees fully participate in and receive the educational benefits provided by the course. Enrollees must demonstrate participation by making detailed postings designed to foster dialogue among colleagues and instructor that reflect the content, skills/ strategies learned and assessments covered in course. These enrollee postings must be made six times each week, in separate sessions, and including a minimum of 4 academic posts and at least 2 peer-peer comments of others' postings and possible shared assignments. Teachers will become familiar with the indicators of drug abuse, and why this knowledge is such a vital part of the educational process, while exploring a variety of strategies in prevention to improve student success. Once teachers are comfortable with such pertinent topics, their competence in the classroom will increase. Educators will enhance their ability to identify causes and types of drugs that are abused for individual students in their classrooms.

By identifying the different types of drugs, educators will address and support the learning needs of their students – this will allow for specific differentiated instruction that will help students become more successful in all classes. Educators will learn how to identify characteristics of a student with drug addiction and how to ascertain appropriate resources for particular students with this condition. Educators will also involve the student in the process of how to create a drug free classroom for their own optimal academic achievement.
